The Board of Directors met on Friday, March 10th. You will be receiving a ballot for updating Article 3 of our governing documents. The purpose is to ensure we maintain our 55+ status. We need to remain in conformity with current law and close loopholes that could be problematic. Please vote. IF YOU DO NOT VOTE, IT IS A VOTE AGAINST THE AMEND-MENT.

Property Manager Report

LakeRidge Falls 55+ Status – LakeRidge Falls offers so many benefits to its members and residents. There is no doubt its amenities, maintenance-free landscape, peaceful scenery, community location, and safety & security are second to none. Above all, LakeRidge Falls' members and residents are what makes LakeRidge Falls a truly great and unique community to live in. One of the main reasons for this is the fact that LakeRidge Falls is a 55+ community. As one can reasonably assume, a community must comply with the rules established by the U.S. Department of Housing and Urban Development (HUD) and the Florida Statutes to be considered a 55+ status. And indeed, LakeRidge Falls' governing documents were drafted and recorded to ensure just that. More specifically, Article III is the main catalyst that allows the Association to restrict occupancy of Lots based on certain criteria thus allowing it to be a 55 and older community.

As we all came to know, lawmakers adopt and amend State and Federal laws mainly because they are constantly being challenged, among other things, by talented lawyers who find legal loopholes in outdated laws. Unfortunately, the same applies to LakeRidge Falls as the Association's governing documents were drafted in March of 2001. Therefore, failure to recognize and adapt to trends and legal changes may only mean the best interests of LakeRidge Falls members are in jeopardy. And indeed, the Association discovered a few legal loopholes through several events that took place in recent years, which may, if not corrected, jeopardize its 55+ status.

Therefore, the Board of Directors discussed this matter during its last meeting. Following a lengthy discussion, the Board approved a proposed amendment to Article III that will ensure and protect the Association against those who challenge its approval process and its 55+ status. With this silly prologue in mind, we know many

By now, you should have received a ballot in the mail asking for your vote on amending Article III. As you can imagine, your Board urges a "Yes" vote on the proposal to amend Article III of the Declaration. It is important to mention that this amendment is strongly recommended by the Association's attorney.

Once complete, please make sure to mail your vote back using the provided envelope. Another option is to fill out the ballot and email it back to us at: PropertyManager@LakeRidgeFalls.Org. You can always drop your vote in one of the gray mailboxes located inside the clubhouse just outside our offices. Please make sure to submit your ballot by June 1st, 2023, at 5 pm. And remember, a no vote is a vote against the amendment as it requires $\frac{2}{3}$ of the membership for approval.

The Story of Bariloche & Fire Safety -

Years ago, which is more like decades ago, I backpacked throughout South America. One of the places I visited was Bariloche (i.e., San Carlos de Bariloche), a picturesque and charming town in western Argentina. Besides its mesmerizing scenery, extreme outdoor activities, and delicious pastries/ice creams, Bariloche offers one special thing. Meat. Lots of meat. You see, Argentinians love their asado, aka barbeque. How much do they love to barbeque one may ask? Well, consider the following interaction I had with a three-year-old boy of a local restaurant owner.

While having lunch, the owner's boy found the group of travelers who I dined with fascinating. I mean, who would not be by a group of six middle eastern, long-hair, hippie-looking group?! Well, at some point, one of the girls in our group asked the little boy, in Spanish of course, what noise the cow makes. Without any hesitation, the boy answered by making sizzling noises while pretending to flip an imaginary steak...

of our residents love to barbeque. However, it is crucial to remember that safety comes first. This is especially true when it comes to multi-unit residential buildings, similar to the 33 buildings located in the Sandstone Falls Neighborhood, i.e., Ashford Falls Court, Cascade Falls Drive, Reynolds Falls Court, and Simpson Falls Court.

Per National Fire Protection Association (NFPA) requirements, the multi-unit residential buildings in LakeRidge Falls are required to follow Florida State-adopted NFPA codes shown below:

2021 Fire Prevention Code

This code requires buildings with multiple units, (more than 3) to <u>have fire extinguishers</u> that are annually inspected and tagged. The extinguishers need to be either installed on the exterior of the buildings so that they are no more than 75 feet of travel for any one unit, or <u>each unit shall have one extinguisher inside</u>.

Storage and Use of Gas Fired Grills, Hibachis, Charcoal or Wood Fired Grills

- 13.1 No person shall <u>place or maintain gas or propane cylinders</u> on porches, breezeways or balconies, or attached garages in multi-unit, multi-story buildings.
- 13.2 No person shall use or operate within any building or structure any unvented fuel or kerosene burning appliance, including those with woven wick, designed for heating purposes.
- 13.3 No person shall store or use charcoal, gas, or wood-fired heaters, grills, barbecues, or any other cooking appliance on porches, balconies, or breezeways in any multi-unit, multi-story building.
- 13.4 No person shall store or use any other heat-producing device or appliance which has been determined by the AHI to be unsafe due to its application or use.

Smoke Alarms

Please also advise the residents to check their smoke alarms to ensure they are in working condition.

We ask all Sandstone Falls Neighborhood residents to take a moment and ensure the above is followed. Mainly, make sure to have a fire extinguisher and smoke alarms and at no circumstance store a propane tank in the unit, not even in the garage. Remember, an action by one resident may have the potential to impact adjoining units in the building. Unfortunately, it is more likely than not that these safety guidelines were written by professionals based on past experiences. For your own and your fellow neighbors' safety please make sure to follow these important directives. Thank you in advance for your attention and cooperation on this very important matter.

<u>Parking on the Streets</u> – Staying on safety-related matters, residents must understand that parking on the Association's narrow roads can be hazardous especially when parking on both sides of the road

and/or parking at night. Now, we can restate the rule, but at times a picture is worth a thousand words, or in this case, a picture taken last month can best emphasize the potential risk of parking on the streets.

Therefore, and with the safety of all in mind, we kindly ask you and/or your invitees to park all vehicle/s in your driveway in a way that does not block pedestrians from safely using the sidewalks, or in the clubhouse parking lot according to the parking lot policy. If you have a construction or service



vendor working on your Lot, please ensure they don't park on the street for longer than reasonably necessary and in a way that does not interfere with traffic, such as parking on both sides of the road. Following such a simple direction will greatly assist us in eliminating potential hazardous and safety incidents such as the one mentioned above. Thank you in advance for your cooperation and understanding on this matter.

<u>Cyclists Safely</u> – Continuing with safety matters, this is a reminder for those who ride their bicycles around the community. Recently, we noticed a few cyclists who were riding on the wrong side of the road. Please, all residents, regardless of if they are riding a bike, driving a vehicle, or walking on foot, must obey all traffic laws and must be aware of their surroundings. Please, residents' safety can't be taken lightly.

On its website, The Florida Department of Highway Safety and Motor Vehicles (FLHSMV) provides great rules for bicyclists as part of its Bicycle Safety Awareness guidance. Here are some important rules appearing on this website:

- Obey all traffic controls and signals.
- Stay alert do not text while biking or wear headphones or earbuds so you can hear everything around you.
- You may use the full lane when making a left turn, passing, avoiding hazards, or when a lane is too narrow for you and a car to share it safely.
- Use directional hand signals to show other drivers that you are about to turn.
- If you are riding on a sidewalk or crosswalk, you have all the rights and duties as a pedestrian. However, you must yield the right-of-way to pedestrians.
- Between sunset and sunrise, you must have a white light visible from 500 feet on the front of your bicycle and a red reflector and a red light visible from 600 feet on the rear. Be seen – wear neon or fluorescent colors and wear something reflective when riding at any time during the day.

- It is recommended that all bicycle riders wear a helmet, no matter your age.
- When riding with others, you may not ride more than two side-by-side unless it is part of a roadway reserved for bicycles; you must ride single file if you and the other rider are impeding traffic.

Remember, together we can keep LakeRidge Falls a safe and enjoyable environment. Please help us by fulfilling your part. We wish to thank you in advance for your cooperation and assistance on this superimportant matter.

<u>Walking at Night</u> – A final note on safety-related matters. A great suggestion was presented to us by a long-time member of the community. It is common sense that walking at night can be less safe than walking during day time. Therefore, it would be best if those who walk their pets at night, exercise in the cooler weather, enjoy roaming the community under the stars, etc. ensure to take a few simple safety measures.

- Please make sure to walk on pedestrian pathways, not the road.
- Always make sure to be highly visible and alert while walking.
- Have a flashlight as it helps you to see your surroundings and allows others to see you.
- Consider wearing reflective gear such as safety vests and flashing armbands.

As with all of the above, your attention and cooperation are extremely important on this matter.

<u>Pond Shoreline Erosion</u> – The Association is dealing, as many other communities in Florida, with pond shoreline erosion issues. To better understand this matter, the Board of Directors established in 2017 a Long-Term Pond Working Group (PWG). The PWG goal was "to study and make recommendations for remediation of current erosion problems as well as a long-term plan to stabilize and or minimize future erosion in our stormwater drainage ponds." It took the group a few years to conclude its work and in 2020 it produced a comprehensive, well-documented, and professional report. We encourage you to take a moment and read the report which is posted on the Association's website under the tab "Special Projects."

Based on this report and in an attempt to develop a community-wide comprehensive action plan to address it, a few test sites were initiated. The goal was to evaluate the impact of the measurements taken and their effectiveness in combating pond erosion. One of the test site projects was named Pond Project 8, aiming at evaluating solutions to two main known contributors to shoreline erosion: residential downspouts and natural drainage swales. As was shared with the community, this project was initiated in May of last year.

There are two main reasons why we are bringing this matter up. During its first meeting, the newly elected 2023 Roads & Grounds (R&G) Committee decided to establish task forces, called crews, to survey a variety of areas and issues affecting the community, publish the findings, and thereafter draft an action plan to address these issues. As one may reasonably assume, one of the crews established was tasked with surveying the issue of pond shoreline erosion. Therefore, you may notice in the next few weeks a group of three or more people wearing reflective vests walking behind your house. Please don't be alarmed as they are members of the R&G Committee who will identify and assess problem areas.

The other reason we bring this matter to your attention is SAFETY. Please note that some eroded areas are hidden. That is, the eroded area has grass that grew high enough to blend with the uneroded areas. As such, they create a hidden hole, which may be considered a tripping hazard. Therefore, we urge, not to say demand, that residents and their invitees stay at least five feet away from any pond's bank. Please, the safety and well-being of LakeRidge Falls residents is a top priority. Please, your attention and cooperation are extremely important on this matter.

Walking Behind Lots - On a related matter, this will be a great opportunity to speak about the difference between a private **Lot** and a Common Area. Based on the Association's Declaration, Article II, Concepts and Definitions, Common Area is all "... property, including easements, which the Association owns... or use for the common use and enjoyment of the Owners." A Lot, on the other hand, is defined as a "portion of the Community... which may be independently owned... The boundaries of each Lot shall be shown on a Plat..." In super simple terms, a Lot is owned by a member, i.e., the homeowner, while a Common Area is for the use/enjoyment, within limitation, of all members/ residents.

As far as maintenance, generally speaking, a **Lot** is being maintained by the homeowner while

Common Areas are being maintained by the Association. Because a) it is prohibited, per the governing documents, to install fences, b) some homeowners' maintenance responsibilities were assigned to or assumed by the Association, for example, mowing of the grass, and c) the unique building layouts, i.e., a mixture of single-family homes, paired villas, and multi-plex dwellings, distinguishing between a Common Area and one's private Lot can be challenging.

While there are several ways to ensure boundaries between the two are visually noticeable, there is a much easier way to ensure one does not "invade" a fellow neighbor's privacy. It is a simple rule of thumb that says: if there is any doubt, there is no doubt. Simple as that. If you walk your pet, for example, in an open area in proximity to a residential dwelling and are not 100% sure if it is a common area, then implement the rule above and simply walk your pet in a different direction. After all, it is always better to be a good neighbor who respects one's privacy because it promotes a healthy environment which in return makes for a friendly community.

Light Poles on Kariba Path – Those who walk regularly most likely are very familiar with the five globe light fixtures located along the sidewalk that connects the two sections of Kariba Lake Terrace. These light fixtures were installed years ago to promote a sense of security for those who choose to walk at night. If it is parts, such as in the case of broken plastic clips, outdated technology, such as in the case of fluorescent bulbs, materials, such as in the case of discoloring acrylic globes, and cleaning, such as in the case of bugs build up inside the globes, these fixtures required ongoing maintenance that at times proved to be challenging.

Therefore, the Board of Directors decided to consider alternate fixtures that will be easy to maintain while meeting the community-wide standard. However, because residents' security and safety are more important than maintenance and/or architectural considerations, the Board of Directors wanted to ensure the prospective

fixture provided the same, if not better, light spread as the ones currently used. Therefore, one light pole fixture was replaced and tested for the last couple of weeks.



Once determined the fixture meets the safety standard, and after further consideration, the Board of Directors voted during last month's meeting on replacing the current globe fixtures. Following this decision, all five globe fixtures were replaced with the newly approved fixture not before all poles were painted. We are sure many will appreciate the fresh and new look and enjoy the benefits of these fixtures for years to come.

Roofs Informational Forum – Early last month, the Roof Task Force held its third informational forum session. This time around, the Roof Task Force hosted the Association's attorney to discuss matters related to the governing documents and Florida Statutes regarding roofing. If you were unable to attend the meeting, please make sure to watch the recorded session as we are sure you will find it very interesting and most importantly informative.

To watch the meeting, and the first two sessions, please email me and I will be more than happy to send you the hyperlink to this session.

With the above in mind, please mark your calendar for the final Informational Forum meeting:

1. April 10th from 2:30 pm - 4:00 pm, a meeting focused on implementation challenges and draft plan, the final opportunity for questions to the Task Force before drafts are revised and submitted to the Board of Directors and the Architectural Review Board (ARB).

Your attendance is important as these sessions provide a great opportunity to greatly enrich your knowledge thus allowing you to be better prepared for the future roof replacement project.

April Selection: Horse by Geraldine Brooks


