among residents, I will emphatically assert that no action or even discussion to make any changes to our existing security systems have taken place by this Board of Directors.

In closing, I remind everyone, that all actions taken by the Board of Directors are published in the minutes of Board meetings, and **no changes to front gate security** will be found in any such document.

By now, most of you should have started to receive the Second Notice of the Annual Meeting of the membership and election for the Board of Directors. In the envelope, you will see a detailed explanation regarding the meeting and election.

**Please read it carefully.**

**Committee Signup** – On a related matter, the committee signup sheets are now available in the Clubhouse. Members and residents can sign up for the Architectural Review Board, Budget, Buildings, Community Relation, Landscaping, Pool, Roads & Grounds, and Security Committees. The Board of Directors encourages homeowners and residents to join the different committees as it provides a feeling of ownership and is a great opportunity for you to become active and involved within the LakeRidge Falls community as committees play a vital role in the operation of LakeRidge Falls.

**Ponds Crew** – Here is an example of how committees play a vital role in the operation of LakeRidge Falls. If you may remember, a couple of months ago we reported about the Roads & Grounds (R&G) Committee's work with a promise to continue sharing more in weeks to come. For those who may recall, here is a short recap of the issue.

One of the best-known committees is the R&G Committee. In early February, just after the new Board of Directors was elected, the R&G Committee was tasked with examining maintenance concerns related to pond erosion, sidewalks, street lights, mailboxes, and recreation amenities. Because this task encompassed vast areas, the R&G Committee decided, with the Board's blessing, of course, to divide the committee into five crews. In general, each crew was tasked with surveying these areas, writing a report regarding its findings, and thereafter presenting a course of action to address such issues. The R&G Committee would then review the work and recommendations and determine what should be the final recommendations to be brought in front of the Board of Directors.

A couple of months ago, we described in length the work of the Street Lights Crew. Today, we will take a moment to speak about the Ponds Crew. In general, the Crew's task was to:

- Survey the Association ponds.
- Identify erosion and other issues that may impact the structural integrity of the ponds.
- Measure the extent of the erosions along the edges of the ponds.

Once concluded, the Ponds Crew was to issue a report to the Board of Directors which would:

- Share the information and data collected.
- Provide possible explanations for erosion causes.
- Recommend solutions to address issues discovered.

After six months of physically inspecting, measuring, and documenting the ponds, the Crew submitted to the Board of Directors, during its August meeting, an impressive 135-page report of its findings and conclusions. However, the members of the Ponds Crew didn't lounge around. Since August, the Crew has been endlessly working on drafting an action plan for the third test site, i.e., the first is the one implemented at Pond #8, and the second one implemented at Pond #14. Once concluded, the Crew held a PowerPoint presentation to the Board of Directors during a recent meeting. The PowerPoint presentation, which is a great testimony of the impressive work done by the Crew, will be posted on the Association's new portal soon.

Of course, and as stated in both the lengthy report and the PowerPoint presentation, this is a long-term project, which would require a realistic budget and time frame. However, none of these would be possible without the hard and dedicated work of the members of the Ponds Crew. Therefore, we are certain all would join us in thanking the members of the Ponds Crew, Mr. Warren Ferry, Mr. Durand Glovinsky, Mr. Bob James, and Mrs. Betty Curry Johnson, the R&G Committee Chairpersons, Mr. David Danilowitz and Mr. Dick Dorn, as well as the Board of Directors Liaison, Mr. Rod Hayden, for a truly amazing job.

**Toys for Tots Campaign** – More than ever, this year's Toys for Tots campaign was a major success. Over seven full cartons of toys and a brand-new bicycle were collected!! All of this would not be possible without the generosity of LakeRidge Falls' residents and the out-of-the-ordinary work of the Community Relations Committee (CRC), which initiated a brand-new event this year called Santa's Festive Golf Cart Sled. During this program, members of the CRC led by Mrs. Barb Weigand, Mrs. Carol Brantley, Mrs. Sue Selvidio-Stanley, Mrs. Jolene Ruffo, and Ms. Susan Tucker were dressed as Elves, accommodated by Mr. Joe Stanley, who was dressed as Santa, drove around the community singing, collecting toys, and spreading the joyful spirit of the holiday. This would be a great opportunity to also thank Mr. Joe Ruffo and Mr. Ray Weigand, who were part of Santa's entourage, as well as the other members of the CRC, Ms. Carol Lockwood, Ms. Nancy Mendelson, and Mr. Dan Meintel. **Applying to the Architectural Review Board (ARB)** – A recent inspection of the community as a whole revealed a significant number of violations of Article V of the Declaration of Covenant, Conditions, and Restrictions of LakeRidge Falls.

As all should know, the Association governing documents, Article V, Architecture and Landscaping, 5.1, General states that "[n]o structure or thing shall be placed, erected or installed upon any Lot, and no improvements or other work (including, without limitation, staking, clearing, excavation, grading, and other site work, exterior alter-

-ations or additions, or planting or removal of landscaping) shall take place within the Community, except in compliance with this Article and the Architectural Guidelines.”

For this reason, members of LakeRidge Falls are required to obtain an ARB approval in writing before any changes are made, for example when one wishes to extend a lanai, install a generator, install hurricane impact windows, etc. Therefore, homeowners who wish to perform landscape and/or exterior architectural changes are required to use an ARB Form, which is available at the clubhouse and on the LRF website: [www.LakeRidgeFalls.org](http://www.LakeRidgeFalls.org) under the section titled Forms.

Please note that all ARB Forms must be filled out, dated, and signed by the homeowner. In addition, the form must be accommodated with an 8” by 11” sheet of paper either legibly printed or typed with a detailed description of the proposed change, addition, or installation.

Furthermore, requests must be accompanied by a copy of an owner’s Plot & Site Plan, i.e., survey, for all ARB Forms involving landscaping, extensions of a building or pools, and, if possible, a photo showing the exact location of the project. A scale drawing may be substituted for the Plot & Site Plan in the event an owner cannot locate the original document. A photo or a drawing to scale but not a survey is required for all other proposed modifications, such as replacements of windows or installation of hurricane shutters.

Plans and specifications shall show, as applicable but not limited to, dimensions, structural design, exterior elevations, exterior materials and colors, landscaping, drainage, exterior lighting, irrigations, and other features of proposed construction or other activity as the ARB deems relevant.

Most importantly, the ARB must receive all ARB Forms no later than forty-eight (48) hours before the scheduled ARB meeting to allow ARB members to review the ARB Form and to visit the site, if necessary, before meeting deliberations. ARB Forms received less than forty-eight (48) hours before the ARB meeting may be “held” for review and consideration at the next scheduled ARB meeting.

Following the guidelines above would ensure you comply with the Association’s governing documents, prevent frustration that may arise due to non-compliance matters, and assist greatly in preserving the community’s architectural integrity, harmonious design, and aesthetic principles. We thank you in advance for your attention and cooperation on this matter.

**Pool** – As some may have noticed, the Association’s long-time and unwelcome friend, the notorious Murphy, aka Murphy’s Law, came for a visit during Thanksgiving. Here is yet another fun story of how Murphy stole Thanksgiving.

On Friday after Thanksgiving, we got a few reports that the pool temperature was cold, very cold. Acting on it, we placed a service call with Geothermal Innovations, LakeRidge Falls’ pool/spa geothermal system maintenance company. Unfortunately, they were unable to come out before Monday the following week as they were busy chasing Murphy out of other communities. On Monday, a Geothermal Innovations tech noted that the lake pump, the one that pumps water from Pond #8 which is used to warm the pool water in the heaters, lost its prime. In simple and not technical terms, what it meant was that air gaps in the line cause suction to stop. No suction, no pressure. No pressure, no heating. The tech theorized that the power outage that took place on Wednesday of last week had something to do with that. However, it is beside the point. The issue was resolved, and the system was up and running again. Or so we thought...

As days passed by it was noted that while the pool temperature went up, it didn’t quite reach the desirable level of 87 degrees. As we came to learn, the reason for this was two-fold. One had to do with the “fight” between the very cold nights we experienced last month and the heating system’s attempt to keep the pool temperature at 87 degrees. As one can imagine, this was not an easy task considering the amount of energy required to do so. The other reason had to do with the age of three of the heaters. As was reported, the pool temperature is regulated by 6 units. If not all 6 units are working in synergy, the system

would struggle to keep the pool at 87 degrees. And indeed, we were informed that unit #6, an original unit, was low on freon. As a result, it was kicking out low pressure. While five units can keep the pool at 87 degrees, it would struggle to do so during overnights of very cold temperatures.

The good news is that Geothermal Innovations swapped the leaking unit with an old unit we kept. And indeed, we are happy to announce this solved the problem as the pool temperature is once again at 87 degrees. With this in mind, we wish to thank all residents for their understanding and patience during the week Murphy was in town.

**Pool Courtesy** – As many know, the pool operation hours are from dawn to dusk. Therefore, the current pool hours are 6:50 am to 6:00 pm. With this in mind, we wish to kindly ask residents who use the pool in the early hours of the morning to please avoid any excessive noise as there are residents who reside near the pool area. Thank you so much for your attention and cooperation on this matter.

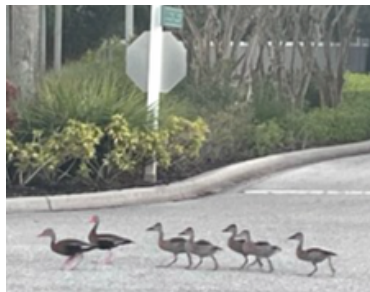
**Pool Bathroom** – As a final piece related to the pool, a few weeks ago we received a report that one of the automatic faucets in the men's bathroom located at the Annex Building was not working. After further investigation, it was determined that the faucet had a faulty solenoid. Without going into too much detail, the purpose of the solenoid is to control the flow of water. So, when one places her/his hands near the faucet's sensor, a signal is sent to the solenoid to turn the water on. Therefore, the part was replaced, and the faucet is up and running again.

**Palm Trimming** – As may have noticed, palm pruning took place last month in the community. This time around, we were focusing on trimming the seed pods from the Foxtail and Queen Palms and the dead fronds of the Queen Palms, i.e., Foxtail Palms are self-shedding. Per Tia Silvasy, a University of Florida Horticulture Extension Agent in Hillsborough County, "the point of pruning should be primarily to remove dead growth. palms need their leaves to photosynthesize and produce food for the plant. Removing too many leaves will result in less food for your palm tree." To read the complete article please use this web address:

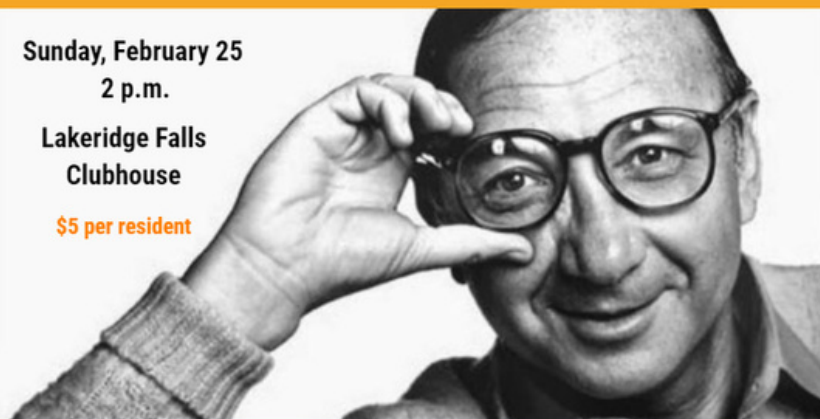
