A Message from Your Board...Thinking Ahead, Working Together

August in Southwest Florida is our annual paradox: the days are long and lazy, but the fast-moving thunderstorms show up on cue every afternoon. Pool decks get quieter, morning walkers shift to earlier start times, and the savvy among us make sure patio furniture goes inside when the radar turns red. In short, it's the stretch of summer when a little neighbor-to-neighbor cooperation—like keeping an eye on a traveling neighbor's home or passing along a heads-up about a leaky irrigation—helps keep the community buttoned up until cooler and more gentle breezes arrive.

While Mother Nature does her thing, the Board is working on its own forecast—digital, not meteorological. At the July Board meeting, I mentioned that we've begun exploring the possibility of implementing electronic voting and notifications. Speaking of the next Board, here's your friendly nudge: the 2026 election cycle starts sooner than you think. Candidate intent forms are due December 31, 2025, with voting slated for January. Serving as a Director is equal parts responsibility and reward—plus a guaranteed front-row seat to the inner workings of Lakeridge Falls. The CRC will again host a "Meet the Candidates" night, and every current Board member is happy to grab a coffee, walk the grounds, or take a call to answer questions about the role. If you've ever said, "Someone ought to...," congratulations—you may be that someone.

Enjoy the last full month of summer, keep an eye on the skies, and consider putting your name on that candidate form. As always, we're only an email—or a friendly call—away.

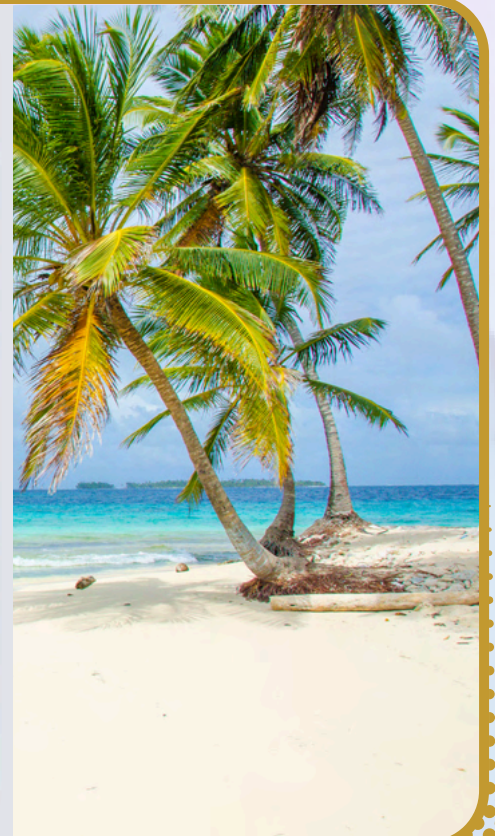

COMMUNITY MANAGER REPORT - ODED NEEMAN

ARB GUIDELINES/PAINTING – During its last meeting, the Board of Directors accepted a recommendation by the Architectural Review Board (ARB) to amend the appendices to Article 18, Painting, Assigned Schedule and LakeRidge Falls Exterior Painting Specifications. While a decision was made years ago to set the painting schedule for every ten years, Florida's climate and weather, which can be harsh and relentless at times, have led various ARBs to reconsider this recommendation. While an average painting job might hold up to 10 years, some of the previous less-than-satisfactory quality painting jobs and various hurricane protection-related work, such as window impact windows and shutters, have led to the conclusion that repainting should be performed sooner rather than later, i.e., every seven years.

While setting a new schedule is relatively easy, setting specifications that would ensure the quality execution of such a project is more complex. For example, firsthand experience from the past couple of years has taught us the importance of digging around the house before painting the walls of the house. You see, many members of the community hired painters who simply repaired and painted the exposed stucco leaving the portion that is covered with soil or mulch untouched. The problem with that, the ARB learned, was that hydrostatic pressure drives the water that drains along the house into the gaps and cracks in the stucco. From there, as one can imagine, the water infiltrates the house, leading to puddles on the floor, moisture seeping down the walls, and the development of mold or mildew. Therefore, the ARB has worked for the past few months on creating specifications that should guide members in ensuring they achieve the best quality of work possible.

With the above in mind, and as can be read between the lines of the revised specifications, the ARB also worked for the past few months with a Sherwin Williams Design Color Specialist, who has close to 30 years of experience in the field, on establishing a variety of potential new and fresh color schemes. The goal of the ARB was mainly to modernize the community while preserving its architectural integrity, harmonious design, and aesthetic principles. Therefore, please make a note that the Board of Directors is planning on holding a Paint Workshop on September 29th, 2025, at 1:00 PM in the Association's Clubhouse and via Zoom.

The purpose of the meeting is to introduce the proposed colors, meet and interact with the Sherwin Williams Design Color Specialist, and receive feedback from members. Only after such a meeting would the Board of Directors consider whether to adopt, amend, or reject the recommended proposed colors. Please make sure to mark your calendars!

EXTERIOR PAINTING SPECIFICATIONS

- i. The exterior of each residential structure is required to be repainted within the time schedule specified in the Documents, ~~which is currently 10 years~~, in compliance with the following specifications:
 1. Expose all stucco covered by soil and/or mulch;
 2. Power-wash all surfaces to be painted;
 3. Patch and caulk as needed;
 4. Prime the exterior using LOXON Concrete & Masonry Primer/Sealer or a similar product;
 5. Paint with at least two coats of exterior Satin paint with based on the a manufacturer's specifications warranty of at least 15 years;
 6. Doors may be painted using Satin or Flat.
 7. The stucco, garage door, front door, trim, columns, soffits, downspouts, and window mullions color shall be painted or replaced and the colors shall be in compliance with the Assigned Paint Color Scheme chart. Lanai and lanai extension aluminum screened enclosures [AKA "pool cages"], screen door framing and screening fabrics are not required to be painted under these Paint Specifications.
 8. Carriage lights shall be painted or replaced ~~See~~ according to ARB Guidelines, Article 28 for numbers of new lights for your structure;
 9. All work to be done in a workmanship like manner;
 10. All owners living in multiple dwelling units need to agree to a color change, or the original color shall be used;
 11. Owners may choose a door color from the approved color scheme according to their preferences.

POOL PUMP – At least once a month, we like to share an example of the importance the committees play in the efficient operations of the Association. Today, it is the turn of the Pool Committee.

Those who were using the pool in recent months could not miss the sounds coming from the pool equipment area of a jazz-like band composed entirely of malfunctioning vacuum cleaners trying their best to play a symphony. The source of this car key screeching noise was originating from the pool's 7.5 horsepower pool pump. On a serious note, the reason for the loud noise, just in case you were wondering, was the pool pump bearings. In super simple terms, without a nipple to regularly grease the bearings, there is an increase in friction, which would eventually lead to failure. Or in other words, it was a sign the pump needed major maintenance work, or it would have failed.

Needless to say that such work or potentially failure would have meant that the pool would have had to be closed for an extensive period. After all, the pool can't remain open without circulation because any chemical used to ensure safe usage of the pool would not be evenly distributed throughout the pool water, thus making it unsafe to use. In case of a failure, for example, that would have meant weeks of waiting. This is mainly because pool pumps of such a size are not something local pool maintenance stores carry in stock. They are special orders, and as such, the wait time can reach up to four weeks.

Knowing the old Val-Pak's 7.5HP pool pump was installed in 2013 and with a few maintenance issues that arose a couple of years ago, the Pool Committee, based on the directive of the Board of Directors and with the assistance of the Budget Committee, adopted a preemptive approach. After some research, an order was placed in 2023 with Water Equipment Technologies of Southwest Florida (WET), the Association's pump maintenance company, for a new pump. In addition, it was decided that the new pump will be stored in WET's facilities until the time comes to replace the old one. This time around, however, the decision was to go with a plastic pump and not a cast-iron one. The main reason behind this decision had to do with the fact that cast iron pumps corrode over time. Besides the deterioration of the pump and motor, the release of such metals into the pool causes staining on the pool surface.

So, with all of the above fun facts and history, we are more than happy to advise that a decision was made to go ahead and replace the pump before it is too late. Therefore, WET techs were on site last month to switch the pumps. Needless to say that because the plans were stored in the drawer for two years, it took the techs a couple of hours to perform the job. As such, PoolWerx, the Association's pool and spa maintenance company, was able to ensure the pool is safe for usage thereafter. So you see, thanks to the hard work of the Pool Committee, members, residents, and guests can continue to enjoy the Association's number one amenity without interruption. We are certain all will join us in thanking the Pool Committee for a job well done.



LANDSCAPE ENHANCEMENT ON LAKERIDGE BLVD – Lots of landscape work took place last month. As part of the Long-Term Landscape Plan BrightView Landscape, the Association landscape maintenance company, was on-site enhancing three landscaping beds along LakeRidge Blvd near Ponds 12 and 13. Because we all love history, here is a short recap of this work.

Back in 2017, a Long-Term Landscape Group was established to develop “a long-range plan for the Community landscaping infrastructure.” That is, the Group was to create a long-vision landscape architecture design to achieve a unified environmental and aesthetic look for LakeRidge Falls’ common landscape areas (i.e. as opposed to members’ Lots). The Group's first task, thereafter, was to establish a core set of guidelines for its vision, which are:

- Establish a 10-Year-Plan;
- Use Florida Friendly and Tropical Plants;
- Utilize easy-to-maintain plant material;
- Create a Park-like Like Setting;
- Avoid Queen Palms while using more Foxtail and Pygmy Palms;
- Acknowledge that Oak Trees are here to stay;
- Follow the notion that Less is Better;
- Ensure the Tier Effect continues throughout.

Following the establishment of the plan’s pillars, the Group went to work. Over four years the Group worked closely with West Bay Landscape, which is now, as we all know, BrightView Landscape, Architectural Landscape Designers, Account Managers, and Arborists on a detailed and comprehensive plan. Once concluded, the Group presented its final report to the Board of Directors, which adopted it thereafter. 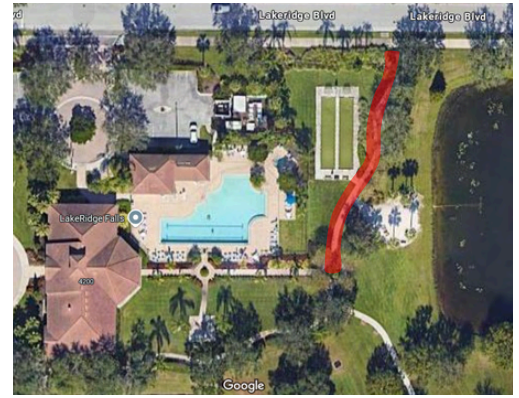


Back to the enhancement work performed this week, BrightView did an amazing job, as can be seen in the before & after pictures below, boosting the total appeal of the community. More importantly, it is yet another clear step toward where the Association wants to go while following a responsible fiscal approach.

STREET LIGHT CREW – Those who walk the community last month could not have missed the trench along the sidewalk located just east of the Pool and Bocce Courts. Here is the story behind it.

A couple of years ago, the Roads & Grounds (R&G), with the approval of the Board of Directors, of course, established a Street Light Crew. The goal of the task force was to survey the community’s street

light poles, identify maintenance issues, and provide suggestions for improvements. Among the several suggestions made, the crew proposed installing 28 pagoda lights, similar to the one used throughout the community, along the pathway from Cascade Fall to the Mi Pueblo Gate to provide a safer walking environment and to promote security.



After some research, fund allocation, and approval from the Board of Directors, the project was executed during the first quarter of 2024, as can be seen in the picture. The success of the project was so significant that several residents pleaded with the Board of Directors to perform the same job along the sidewalk leading from the back of the Clubhouse to LakeRidge Blvd, please see the illustration. Attentive to residents' pleas, the Street Light Crew was tasked with providing input and potential solutions to the subject matter. The Crew went to work, and by September, the Crew presented to the Board of Directors its conclusions. In short, the recommendation was to install the pagoda lights along this section of sidewalk.



In researching the matter, the Crew concluded that such a project would be less expensive if perhaps some of the existing lights along the pathway from Cascade Falls Drive to the Mi Pueblo Gate were allocated to this new project. This assumption was reached after the Crew concluded that the beam spread would not be significantly impacted if some of the fixtures were removed. After some consideration of this project, the Board of Directors approved it and directed the Budget Committee to allocate the proper funds in the 2025 Budget.

As you guessed, this project was concluded recently as can be seen in the picture below:



NORTHERN FENCE – Back in November of last year, we reported about the area behind the berm and the chain link fence located along this northern section of the Association. Really quick reminder for those who may not recall. It is very noticeable that LakeRidge Falls is enclosed with concrete walls along its east, west, and south boundaries. However, not many know that along its north front, there is a chain link fence that separates it from other communities and properties.

As can be seen in the map, the reason why the chain link fence is not noticeable is rooted in the fact that it is “hidden” by a preserved area and a berm. The preserve area, marked with orange lines, covers the section from Lockwood Ridge Rd to about the area where the emergency path is. From there to Tuttle Ave, there is a berm, marked with light blue lines, that “blocks” the view of the fence of the homes along the north part of Mackay Falls Terrace and Stirling Falls Cir.



Also, as reported, Hurricane Milton damaged most of the Association’s grounds, which led to a large cleaning out project resulting in the hauling away of over 250 tons of landscape debris. During these cleaning out efforts along the easement behind the berm, it was discovered that some trees and branches that fell along this area damaged a handful of sections of the chain link. As one can only imagine, hiring a fence company at time for a reasonable price was a mission impossible. This task was so hard to accomplish that it took the Association six months to locate a vendor and then two additional months to be placed on the schedule.

Nevertheless, last month, USA Fence was on site to perform the repair work. As we say, a picture is worth a thousand words, so please allow the before and after pictures to tell the entire story.

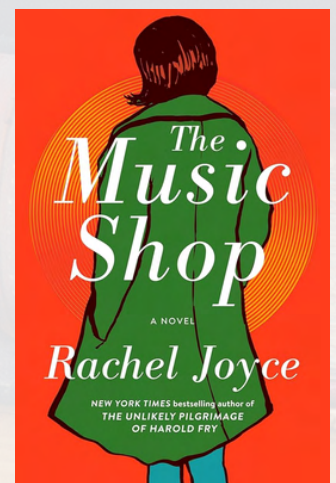
The Music Shop by **Rachel Joyce**

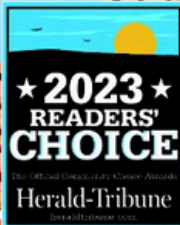
