

With this in mind, you should start receiving the Second Notice of the Annual Meeting of the membership and election for the Board of Directors. In the envelope, you will see a detailed explanation regarding the meeting and the election process. Please read it carefully. And of course, please don't forget to VOTE!

COMMITTEE SIGNUP – On a related matter, the committee signup sheets are now available in the Clubhouse. Members and residents can sign up for the Architectural Review Board, Budget, Buildings, Community Relation, Landscaping, Pool, Roads & Grounds, and Security Committees. The Board of Directors encourages homeowners and residents to join the different committees as it provides a feeling of ownership and is a great opportunity for you to become active and involved within the LakeRidge Falls community as committees play a vital role in the operation of LakeRidge Falls.

RESIDENTS DIRECTORY – As every year, we start working on the 2026 Directory. We are asking residents who wish to add or update (no need to submit a form if you don't wish to make a change from last year's directory) any piece of information, i.e., name spelling, phone number, and/or email address, to please fill out a new Residents Directory and Mass Email Distribution Information Form, which can be found on the Association website and the Association portal. After obtaining the form and filling it out, please return the form to the LakeRidge Falls office. This form will take no more than five minutes to complete but will provide us with the ability to better communicate with our residents. Thank you in advance for your cooperation on this matter.

GATOR NATION – As some Florida State fans out there know, the US in general and Florida in particular are considered a Gator Nation. Therefore, it should not come as a surprise that a few residents reported sightings of an alligator swimming in one of the Association's ponds.

Last month, a few reports came in about a five-foot alligator that was spotted around Pond #12. If you wonder where is Pond #12, please refer to the map on the next page. Following the reports, a call was made to the Nuisance Alligator Hotline, a Florida Fish and Wildlife Conservation Commission program designed to protect the alligator population while keeping public safety in mind. A case file was opened and a trapper by the name of Jimmy was assigned to the case. It took Jimmy a couple of days, but at the end he was able to "harvest" the 5'6" gator.

This is a great opportunity to remind residents to please not attempt to handle any alligator by themselves. It goes without saying, but please never attempt to feed alligators, as it is both dangerous and illegal. Furthermore, please make sure not to leave pet food in the lanai, nor leave a pet there unattended. And above all, please make sure to take a moment and read the brochure called Living with Alligators, which is published by the Florida Fish and Wildlife Conservation Commission and published on both of the Association's website and portal.



VANDALISM AT THE POOL - In the past, we shared several lengthy articles with the community asking residents to take proactive measures in reporting suspicious activities. The following is a good example of how a proactive action could have possibly prevented an unfortunate action from taking place.

On November 12, at around 9:32 pm, two individuals riding bicycles entered the community via the back gate at the same time as a member of the community. One of these individuals was wearing a hoodie. At around 9:33 pm, these individuals were seen arriving at the clubhouse, parking their bicycles, and entering the pool fenced area. At around 10:01 pm, one of the trespassers jumped over the north side gate of the pool after leaving the pool area a few minutes beforehand. At around 10:13 pm, the two individuals left the community from the back exit gate, not before passing by a resident's vehicle that had just entered the community. The following morning, the Association received a few reports from residents that portrayed the acts of vandalism the two individuals had left behind them.

If you think about it for a second, two individuals riding their bicycles at night on the streets of this community is a situation that sticks out like a sore thumb. This is especially true when considering that one of them had a hoodie on. While the Association is obligated to ensure its members and residents are secure and safe, it requires the assistance of its residents. Therefore, residents must understand that they must take a proactive role by reporting any suspicious activity to the Manatee County Sheriff's Department on its non-emergency line at 941-747-3011, or in case of immediate assistance, at 911.



Never confront someone you believe to be a piggyrider, solicitor, trespasser, and/or suspicious person. Please don't attempt to slow down when driving into the community because you feel the person in the car behind you looks suspicious, address individuals walking on the street because you don't recognize them or follow someone throughout the Association's streets because you think the person is a trespasser.



MANATEE COUNTY SHERIFF'S PRESENTATION – On a related matter, in a continuous effort to improve the security and safety of LakeRidge Falls' residents, the Security Committee, with the blessing of the Board of Directors, invited Deputy Tom Kaczmarek from the Manatee County Sheriff's Office to discuss the topic of Home Security and Theft Prevention. For those who were unable to attend, the Security Committee made sure to record the presentation by Deputy Kaczmarek. Therefore, the Committee and the Board of Directors urge all residents and members to take a moment to watch this important presentation. PARKING ON THE STREETS – Staying with safety matters, please take a moment to read this important information. We kindly ask you and/or your invitees to park all vehicle/s in your driveway in a way that does not block pedestrians from safely using the sidewalks, or in the clubhouse parking lot according to the parking lot policy.


Please understand that LakeRidge Falls' governing documents, Initial Restrictions and Rules, Paragraph 2, Restricted Activities, (a), prohibits within the community the ***"[p]arking of any vehicles on private streets or thoroughfares; and parking of commercial vehicles or equipment, mobile homes, campers, and similar recreational vehicles, golf carts, boats, and other watercraft, trailers, stored vehicles, or inoperable vehicles in places other than enclosed garages; however, construction, service, and delivery vehicles shall be exempt from this provision for such period of time as is reasonably necessary to provide service or to make a delivery to a Lot or the Common Area."***

However, enforcement measures are always the last resort. Therefore, if you have a construction or service vendor working on your Lot, please ensure they don't park on the street for longer than reasonably necessary and in a way that does not interfere with traffic, such as parking on both sides of the road. If you have friends or family visiting, please ask them to park their vehicle/s in your driveway in a way that does not block pedestrians from safely using the sidewalks, or in the clubhouse parking lot, according to the parking lot policy. Following such a simple direction will greatly assist us in eliminating potential hazardous and safety situations. Thank you in advance for your cooperation and understanding in the matter.

COMMUNICATION – As reported back in June, the Board of Directors voted on switching communication service providers. It "only" took five months to execute this decision, but this is what makes the Weekly Reports so interesting. So, sit tied and enjoy the story beyond this matter.

Until this week, LakeRidge Falls was utilizing the services of Spectrum for its internet, phone, and TV, i.e., Clubhouse/Pool - internet and phone; Gatehouse - internet, phone, and TV. The relationship, which goes back to the time before Spectrum purchased BrightHouse, is over a decade long. Unfortunately, significant problems with services have surfaced for the past couple of years, mainly administrative and service issues, which led to the decision to switch to Frontier Communications. Regarding administration, it became a major bureaucracy nightmare. The continuous changes within Spectrum over the years have landed the Association under the purview of two different entities, Spectrum Enterprise and Spectrum Business. As one can imagine, this caused a lot of confusion and many problems when a service issue arose. First, attempts to sort out the problem or renegotiate rates have proven fruitless. This is mainly because many of the Association's rates were grandfathered in. Any change, we were advised on several occasions, would have increased the Association rates. It got to a paradoxical reality in which the Association was paying for a phone line it didn't use because it would

have increased its rates to use fewer services...



Regarding service, internet and phone issues have become more and more of a problem. That is, the slower speed and/or dropouts of the internet, which made, for example, during Board of Directors/Committees Zoom meetings, have caused frustration among several members and residents who wanted to participate in such meetings. With the above in mind, knowing that fiber internet is more reliable than coax, and the potential savings in switching providers, the Board of Directors concluded it was time to switch communication service providers.

Therefore, it was reported that the switch was scheduled to take place in late June of this year. But... the project didn't take off. For unknown reasons, Frontier Communications was a no-show/no-call. After some unpleasant conversations with two of their representatives, we were assured they would be on site the following week to perform the work. But... when a Frontier Fiber Field Tech did show a week later, he advised that the job could not be performed as ordered, mainly because there was no fiber connection to the Gatehouse. As a result, we were advised that the Fiber Field Tech had to petition Frontier's Engineering Dept to run a fiber line to the Gatehouse. A process that we were told may take 30 to 60 days to complete. But... it took much longer. How much longer? Well, more like 90 days on top of the less optimistic prediction. Nevertheless, this article is to announce that the wait is over! Last month, four different Frontier Communications representatives were on-site, and the switch was officially completed. That is, the Association is now receiving its internet and phone services from Frontier Communications!

Ok, one may ask him or herself, what does it mean? Well, not much besides improving the internet surfacing experience for those enjoying the Association amenities and the quality of the Zoom broadcasting meetings. Another noticeable change going forward is that callers will no longer be required to navigate between extension numbers when calling the Association's office. This is a good opportunity to advise all that the phone numbers for both the office and gatehouse remain the same. That is, the Gatehouse phone number remains 941-355-1328, and the office number remains 941-360-1046. In conclusion and at the bottom line, this change should save the Association between \$3,500 and \$4,000 a year in communication services. We hope you find this information useful.

FITNESS CENTER – Recently, things got a little bit heated up at the fitness center. So heated up that we got reports about this situation during the weekend... Well, we are speaking about the air conditioning unit at the fitness center, of course. We were informed on Sunday that the air conditioning stopped working. Wasting no time, we placed a service call to Bahama Breeze Heating & Cooling, the Association's air conditioning maintenance company. Upon inspection, it was noted that the condensate drain pan was full of water which triggered the shut-off sensor in the pan. Upon further assessment, it was determined that the unit's coil had a leak, which caused it to freeze.

To better explain the matter, here is an air conditioning maintenance 101 crash course. An air conditioning system relies on a closed loop of refrigerant that circulates between the indoor evaporator coil and the outdoor condenser coil. Here comes the interesting part. When there is a leak in the indoor evaporator coil, it lowers the pressure in the system. This makes the refrigerant extremely cold. Why? Well, the principles of thermodynamics, which are too complex to understand and too boring to care about. So, when the moisture in the room meets the cold refrigerant...well... it turns into ice on the coil. While this can lead to a variety of issues with the unit, in our case, it froze the coil, which led to a pan full of water, which triggered the shut-off sensor. The bottom line, the air

conditioning at the fitness center stopped working. Now comes the good part. Bahama Breeze Heating & Cooling is such a great company that a new coil was ordered and replaced within two days! Just to give you an idea, large projects as this one can take a few days to a couple of weeks to complete. By Wednesday, the unit was up and running like nothing ever happened. We are happy to report that all things in the fitness center cooled down, and residents and guests can once again enjoy one of LakeRidge Falls' best amenities.

Staying on Fitness Center related matters, user of this state of the art facility may surely have noticed that the recumbent elliptical is one of the most popular exercise machines in the center. As such, it didn't come as a surprise when the Association learned it was the first machine to show some signs of wear and tear. A few weeks ago, Fitness Logic, the Association's Fitness Center maintenance company, advised that the machine's housing of the heart rate handles, which are designed to measure the pulse when one grasps them firmly during a workout, broke. Therefore, Fitness Logic had to temporarily glue the housing around the handles so users would still be able to use them and, at the same time, ordered new handles. And indeed, a couple of weeks ago, the new parts arrived and were immediately replaced. Thereafter, the recumbent elliptical was tested and was said to be in great working condition once again.

CARELESS VENDORS – Once again, we are getting reports from residents regarding careless vendors who neglect to maintain a clean working environment. As a result, nails and screws find their way to the Association's roads and sidewalks. Needless to say, no one wants to spend time in a tire shop, and most definitely, not in the ER because a reckless vendor, for example, forgot to clean the gutters after the roof of the house was replaced. In this example, and as can be seen in the picture, at least two dozen of screws and nails were washed away following a heavy rain from the gutters, into of the downspout an and from there into the sidewalk and road.

Therefore, we urge all residents to play a proactive role in ensuring LakeRidge Falls remains a safe and clean community. You can do so by clearly communicating to your vendors that they must regularly tidy up their work area, dispose of debris properly, and double-check for any stray nails, screws, or hazardous materials during and before leaving the site. Please, and again please, make sure to assist the community on this very important matter.

ROOF TILES - On a some what related matter, the Board of Directors has placed a rack in the Clubhouse with sample roof tiles by three different manufacturers. This was done in an effort to make the roof replacement tile selection process easier for members. The eight samples are most of the available tiles that were approved to date by the Architectural Review Board (ARB).

This display allows homeowners to view the different tile options in person to possibly help make informed choices that best suit their preferences. Of course, members are encouraged to stop by to review the samples. We do, however, kindly ask not to remove or touch the sample for your own safety. As always, the members of the ARB and this office are available to assist homeowners with any questions or concerns they may have.




